## ALL PUEBLO COUNCIL OF GOVERNORS **RESOLUTION NO. APCG 2021-09**

## **REAFFIRMING SUPPORT OF THE YAZZIE/MARTINEZ TRIBAL REMEDY** FRAMEWORK AND POSITION ON EDUCATION RELATED MATTERS

WHEREAS, the All Pueblo Council of Governors (APCG) is comprised of the Pueblos of Acoma, Cochiti, Isleta, Jemez, Laguna, Nambe, Ohkay Owingeh, Picuris, Pojoaque, San Felipe, San Ildefonso, Sandia, Santa Ana, Santa Clara, Santo Domingo, Taos, Tesuque, Zia, and Zuni and one Pueblo in Texas, Ysleta del Sur, each having sovereign authority to govern their own affairs; and

WHEREAS, the purpose of the APCG is to advocate, foster, protect, and encourage the social, cultural, and traditional well-being of the Pueblo Nations; and

WHEREAS, through their inherent sovereign rights, the APCG promotes language, health, economic, natural resources, and education equity and advancement of all generations of Pueblo people; and

WHEREAS, Pueblo governments and their tribal members, including those members enrolled and attending New Mexico public schools, possess a unique legal and political status, as set forth in the Constitution of the United States, Treaties, Executive Orders, and court decisions, and are citizens of Pueblo Nations, the State of New Mexico, and the United States; and

San Ildefonso WHEREAS, Based on the Pueblos' political and legal status and tribal members' citizenship status, New Mexico Public Education Department and public school districts are obligated to provide programs and services for Native American students; and

> **WHEREAS**, APCG has established education as a top priority and has a longdemonstrated history of advocacy to impact and create policies and programs, to secure appropriations, and to enact laws at the local, state and federal levels to address the education needs of and create opportunities for its children; and

WHEREAS, APCG publicly expressed and actively supported Yazzie/Martinez Tesuque v. the State of New Mexico, and commended the New Mexico Center on Law and Poverty and all who worked tirelessly in preparing for litigation and those who provided expert testimony during trial, including former Pueblo Governors and Pueblo Ysleta Del Sur education professionals, to realize the historic and landmark 2018 decision declared by the late Honorable Sarah Singleton; and

Sandia	WHEREAS, the recommendations in APCG Resolution No. 2018-21 were fully incorporated into the larger Yazzie Remedy Framework, and endorsed by Jicarilla Apache Nation, Navajo Nation, and Mescalero Apache Tribe; and

San Ildefonso	WHEREAS, the recommendations in APCG Resolution No. 2018-21 were fully incorporated into the broader set of <i>Yazzie</i> remedies developed by Transform Education New Mexico (TENM), an education coalition led by the NM Center on Law

	WHEREAS, in the aftermath of the 2019 session, the APCG co-sponsored with

	WHEREAS, in March 2020, the State of New Mexico filed a Motion to
Acoma	Dismiss the <i>Yazzie/Martinez</i> lawsuit asserting that it had taken steps to comply with the
Cochiti	2018 court ruling and should be trusted to do the rest, which APCG vehemently opposed. At the June 29, 2021 court hearing, the Honorable Judge Matthew Wilson
	rejected the state's motion stating, "Until there are long term comprehensive reforms
Isleta	implemented by the state, the court will maintain jurisdiction over the case."; and
Jemez	<b>WHEREAS,</b> the Tribal Education Alliance has worked with all stakeholders to further refine policies, programs, budgets, and legislative initiatives contained in the 2021 Tribal Dama da Francesco de basis detine and basis and
Laguna	2021 Tribal Remedy Framework legislative package; and
Nambe	WHEREAS, the state Executive recommended \$30 million for the Tribal Remedy Framework in the 2021 legislative session which did not materialize. However, Representative Lente and the Tribal Education Alliance and many
Ohkay Owingeh	stakeholders successfully secured \$16 million in appropriations identified as Phase I of funding for the Tribal Remedy Framework; and
Picuris	WHEREAS, in December 2020, the Yazzie Plaintiffs' filed an Expedited Motion
Pojoaque	for Further Relief Concerning Defendants' Failure to Provide Essential Technology to At-Risk Public School Students, asserting that students, especially those in rural and
Sandia	predominately Native American school districts, who cannot access remote learning because they lack a computer and/or access to high-speed internet are effectively being denied all opportunities for a uniform and sufficient education; and

San Ildefonso	WHEREAS, at the April 30, 2021 court hearing, the Honorable Judge Matthew Wilson ruled the state must comply with its duty to provide a uniform and sufficient education and may not conserve financial resources at the expense of its duties under
Santa Ana	the state constitution, and ordered the state to immediately provide computers and high- speed internet access to the thousands of at-risk students and their teachers who lack the
Santa Clara	tools necessary for remote learning and funding for qualified information technology staff to support students' remote learning needs, both presently and post-pandemic; and
Santo Domingo	NOW THEREFORE BE IT RESOLVED, that the APCG reaffirms its
Taos	support and commitment to the Tribal Remedy Framework legislation as introduced in the 2021 legislature, as those proposals are aligned with the <i>Yazzie/Martinez</i> court decision and order and findings of fact and are consistent with the recommendations
Tesuque	resulting from Pueblo Community Education Institutes from which those legislative proposals were drafted and introduced on behalf of our Native children and tribal

Cochiti	ruling of the U.S. Department of Education Impact Aid Office and be kept separate from the state's obligations under the <i>Yazzie/Martinez</i> court ruling; and
Isleta	<b>BE IT FURTHER RESOLVED,</b> that the APCG requests the state to consult and coordinate with the respective tribal education departments in the development of a
Jemez	statewide plan to ensure all Native American students have access to digital devices and high-speed internet at home to participate in remote learning now and in the future, consistent with the court ruling on <i>Yazzie</i> Plaintiffs' motion regarding access to
Laguna	technology; and
Nambe	<b>BE IT FURTHER RESOLVED,</b> that APCG requests the support of the Leadership Institute and Tribal Education Alliance to collaborate with the APCG
Ohkay Owingeh	Education and Legislative Committees to organize an APCG Community Education Institute for the purpose of reviewing all education initiatives to reaffirm the collective
Picuris	efforts to achieve the outcomes of the Tribal Remedy Framework recommendations; and
Pojoaque	BE IT FINALLY RESOLVED, that APCG Chairman Wilfred Herrera and
Sandia	presiding officers are authorized to pursue efforts with the state Executive and Legislature to fulfill the intent and purpose of this Resolution, and call upon the State of
San Felipe	New Mexico to fulfill its obligations as mandated by the 2018 <i>Yazzie/Martinez</i> decision and order and the 2021 court ruling regarding access to technology, to fully address the unmet needs of Native students by implementing and fully funding tribal proposals
