Court ruling: April 30, 2021, Judge Matthew Wilson ruled in favor of the *Yazzie* Plaintiffs' **Technology Motion**, which asked the State to address the lack of access to technology and internet during the pandemic for "at-risk" students, particularly Native students.

APCG 2021-09** (May 27, 2021) REAFFIRMING SUPPORT OF THE YAZZIE/MARTINEZ TRIBAL REMEDY FRAMEWORK AND POSITION ON EDUCATION RELATED MATTERS The APCG "reaffirms its support and commitment to the Tribal Remedy Framework legislation as introduced in the 2021 legislature, as those proposals are aligned with the *Yazzie/Martinez* court decision and order and findings of fact and are consistent with the recommendations resulting from Pueblo Community Education Institutes from which those legislative proposals were drafted and introduced on behalf of our Native children and tribal communities."

The APCG calls upon the State "to fully address the unmet needs of Native students by implementing and fully funding tribal proposals contained in the Tribal Remedy Framework."
